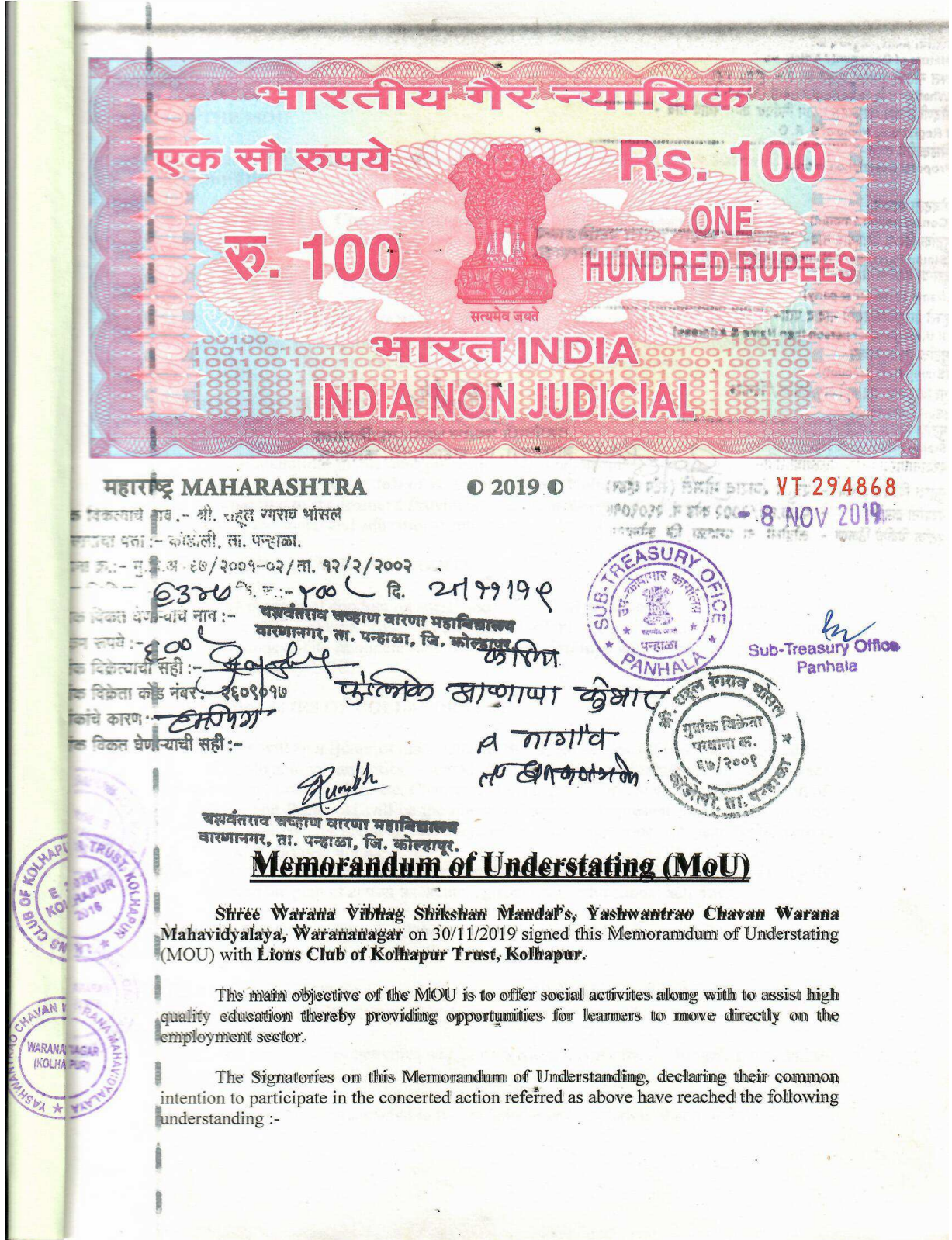

CL.1.2 **Yashwantrao Chavan Warana Mahavidyalaya, Warananagar** Affiliated to Shivaji University, Kolhapur (herewith called the PARTY of the other part)

C.L. 2. PREAMBLE

C.L. 2.1 WHERE AS the PARTY is Desirous of collaborating with **Lions Club of Kolhapur Trust, Kolhapur** now therefor, in consideration of the premises and mutual covenants here-in- after contained, the parties here to agreed as follows –

CL.3 SCOPE OF THE MOU

C.L.3.1 The agreement details the terms and condition, financial arrangements, modalities of collaboration, intellectual property rights, responsibilities and obligations of the PARTY and **Lions Club of Kolhapur Trust, Kolhapur**, Pertaining to the hands on training to the learners, Providing visiting faculties and successful conduction of the of the social and educational activities.

C.L. 4 FINANCIAL ARRANGEMENTS

C.L.4.1 The purpose of conducting social and educational activities useful for them to foster global change. Thus it is important for both the parties since it saves the time and money. The remunerations for the guest faculties will be paid as per the rates prescribed by UGC.

C.L.5 MODALITIES OF COLLABORATION

C.L.5.1 There will be a Board of management (BOM) for successful condition of social and educational activities. BOM shall include representatives of the relevant institute, Local bodies, etc. Chairman Managing Committee will be the Chairman of BOM and Prinicpal will be the member Secretary, Representative of partner lions club shall be its member secretary, BOM shall meet once in year for effective working of programme.

C.L. 5.2 **Both the Parties** Shall jointly identify the skills and need based activites and will prepare the plan of action to excute the social and educational activities.

C.L. 5.3 Students of the collage will be allowed to visit the laboratories/ Workshop for orientation.

C.L.5.4 The Collage will provide infrastructure to social and educational activites to be held at the partner institute.

C.L. 5.5 The main focus of activities will be on Vision, Envorinment, Hunger, Youth and s-ocial services.

C.L. 6. Certificates will be awarded to the students after completion of activities.

C.L. 8. EFFECTIVE DATE, DURATION, TERMINATION OF THE AGREEMENT

C.L. 8.1 The Memorandum of Understanding Will remain in force calculated from the date of first meeting of the Management Committee. It will remain continuous until and unless it is terminated by the mutual consents of the parties.

C.L.9 NOTICES

C.L.9.1 All the notices and information will be communicated through print or paperless media with the mutual understanding between both of parties.

C.L.10 AMENDMENTS TO THE AGREEMENT

C.L.10.1 No amendment or modification of these agreements shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be an amendment of this agreement in the BOM meeting . the Modification / Changes shall be effective from the date on which they are made/ executed, unless otherwise agreed to.

CL.12 ASSIGNMENT OF THE AGREEMENT

CL.12.1 The rights and liabilities arising to any this agreement shall not be assigned except with written consent of the other party and subject to such terms and conditions as may be mutually agreed upon.

CL.13 ARBITRATION

CL.13.1 Except as hereinbefore provide, any dispute arising out of this agreement, the same shall be reherred to the arbitration of arbitrators, one to be appointed by each party to the dispute, and in case of difference of opinion between them to an umpire appointed by the said two arbitrators before entering on the reference, and decision of such arbitrators or umpire and the arbitration proceedings shall take place under the Indian Arbitration Act, 1996.
