MEMORANDUM OF UNDERSTANDING

Memorandum of Understanding between the Yashwantrao Chavan Warana Mahavidyalaya, Warananagar - 416 113 and the Maruti Charitable Trust, Kekhale, Tal. Panhala, Dist. Kolhapur. 416113, a NGO

aiming Socio-cultural activity, Health, Sports, Plantation, Cleanliness drive, Introduction to Ayurveda and medicinal plants.

Yashwantrao Chavan Warana Mahavidyalaya, Warananagar - 416 113 is established by Shri Warana Vibhag Shikshan Mandal, Warananagar in 1964 affiliated to Shivaji University, Kolhapur.

This Memorandum of Understanding entered into on 05.02.2022 at Warananagar, Panhala between the **Yashwantrao Chavan Warana Mahavidyalaya, Warananagar - 416 113**, imparting and offering educational courses herein after referred to as (YCWM) located at Warananagar-416113, represented by the Principal of the College which expression shall unless repugnant to the context means and include its successors and assigns of the ONE PART.

Maruti Charitable Trust, Kekhale is an organization of Folk Medicine Practitioners, with experts in Naturotherapy, Taxonomy i.e. identification of plants, Pharmacists, Chemists, Microbiologists, since 2013. Maruti Charitable Trust is one the reputed NGO in Western Maharashtra. Maruti Charitable Trust presently focusing on Ayurvedic Medicinal Research and Treatment, biodiversity monitoring of plants, Effect mining on the biodiversity of Western Ghats, Soil Conservation, Focusing and Saving of Endangered Species of plants (Red Species) Maruti Charitable Trust is represented here by Mr. Sushant S. Patil, President of Maruti Charitable Trust (hereinafter referred to as Maruti Charitable Trust) which expression shall unless repugnant to the context mean and intrude its successors and assigns of the OTHER PART.

WHERE AS the YCWM has decided to recognize Maruti Charitable Trust is a registered NGO as decided by the Syndicate of the YCWM and to recognize to share expertise in Chemist, Botanist, NSS, NCC, training facilities and counseling providing information about job opportunities, study of biodiversity of plants, conservation, restoration dissemination of

knowledge, and information about nature among students and laymen in collaboration with YCWM.

The parties have had preliminary discussions in this matter and have as certain areas of broad consensus. The parties now, have therefore, agreed to enter in writing these areas of consensus, under a Memorandum of Understanding.

Now this Memorandum of Understanding witnesses that:

The **Maruti Charitable Trust** shall offer the following opportunities for the students of the YCWM.

1. Study of biodiversity of plants, environment, ecology.
2. Participation in various nature related programs, research and nature awareness activities arranged by Maruti Charitable Trust

The YCWM shall offer the sharing of human resources and library facilities for members, participants in various activities, research workers offered by the **Maruti Charitable Trust**.

1.0 RESPONSIBILITIES OF APPROVED INSTITUTION i.e., Maruti Charitable Trust

- 1.1 Maruti Charitable Trust shall provide recent information of 'jobs and training course' concern with nature and environment in India and abroad to the students of YCWM those whom deserve the membership of Maruti Charitable Trust.
- 1.2 Maruti Charitable Trust shall neither offer any kind of remuneration or stipend nor shall they collect any amount under any head from the students joining the 'Maruti Charitable Trust' as member.
- 1.3 Maruti Charitable Trust shall decide selection of students of YCWM for various programs and activities of organization.

- 1.4 Maruti Charitable Trust shall suggest vacancies of job for the regular enrolled students of the YCWM so as to help to improve financial condition of the students.
 - 1.5 Maruti Charitable Trust shall not decide the amount and mode of payment and service conditions of employee who deserve service suggested by Maruti Charitable Trust.
 - 1.6 The expenses in connection with regular lectures, practicals, remuneration to teaching faculty and internal evaluation will NOT be borne by Maruti Charitable Trust.
 - 1.7 The registration, training programmes and any activity, workshop if any shall be framed and managed by Maruti Charitable Trust. In this regard, the suggestions offered by YCWM will be taken into consideration, wherever necessary.
- 2.0 RESPONSIBILITIES OF THE YCWM**
- 2.1 The list of the enrolled students for activities and various programs organized by Maruti Charitable Trust shall be provided to Maruti Charitable Trust by YCWM.
 - 2.2 The YCWM shall monitor the progress of the participant students joining various programs and activities offered by Maruti Charitable Trust.
 - 2.3 The YCWM shall provide details of the students those are eligible and show willingness to participate in various programs and activities offered by Maruti Charitable Trust.
 - 2.4 The YCWM shall respond to the communication of Maruti Charitable Trust regarding various programs and activities offered by Maruti Charitable Trust.
 - 2.5 YCWM shall provide list and contact numbers of the eligible students of the institution.
 - 2.6 The YCWM shall provide infrastructure facilities, library and staff for the various programs and activities offered by Maruti Charitable Trust.

2.7 The YCWM shall provide Human resources for lecture, practicals for conducting of various programs and activities offered by Maruti Charitable Trust.

3.0 JOINT RESPONSIBILITIES OF YCWM AND MARUTI CHARITABLE TRUST

3.1 This MoU shall be valid for a period of three years from this date and can be renewed for a further period of three years on mutual consent.

3.2 Any expansion or modification relating to the academic programmes shall be decided jointly by the YCWM and Maruti Charitable Trust.

3.3 Any legal implications will be confined to Panhala, Kolhapur Jurisdiction only.






