The first lesson of higher education was started in the rural area and it is continued till day. In those five and half decades the institution has been imparting on behalf of rural upliftment. The intuition further desires to provide need based course to impart skills among the learners.

AND WHEREAS it has been considered experiment to agree in writing to participate jointly in undertaking students and faculty related assignment to enhance the quality of colleges as per the expertise and logistics available with both the PARTIES.



### Article 1. OBJECTIVES

- 1.4 Organization of joint Activities in Research and Teaching - Learning activities.

### Article 2. Forms of Cooperation

- 2.1 Joint Research Project.
- 2.2 Academic Projects/ Programme.
- 2.3 Seminars and Lectures on Topics of Mutual Interest and Relevance.
- 2.3 Faculty- Students Exchange.
- 2.4 Teachers and Students Training Programme.
- 2.5 Academic, Sports and Cooperation in College cultural activities.

### Article 3. CONSULTANCY AND EXTENSION ACTIVITIES

- 3.1 Joint Collaborative Projects.
- 3.2 Research Guidance and Collaboration.
- 3.3 Sharing of Infrastructure and teaching instruments.
- 3.4 Sharing of tools and techniques and knowledge in various disciplines.

### Article 4. EXCHANGE OF INFORMATION AND RESEARCH SAMPLES

- 4.1 The term 'Information sharing' includes scientific or technical data, tools, results and /or methods of investigation, and other information intended to be provided, exchanged or arising under the objectives identified under Article 3. The PARTIES shall take all measures to protect the secrecy of and avoid disclosure and unauthorized use of the information which is confidential and outside the public domain.





4.2 Knowledge exchanged between the PARTIES shall not be transferred to any third party for research and commercial purposes and that the unutilized portions of such samples must be sent back to the concerned coordinators.

**Article 5. PUBLICATIONS AND INTELLECTUAL PROPERTY RIGHTS**

- 5.1 Any research publications and intellectual property rights arising out of the students and joint research projects shall be jointly published and when patented, will be jointly and equally owned by SWBM, Warananagar and YCWM, Warananagar.
- 5.2 The procedural formalities for securing and maintaining the intellectual property rights shall be the responsibility of both SWBM, Warananagar / YCWM Warananagar and the expenditure incurred there of shall be borne jointly and equally by SWBM, Warananagar / YCWM.
- 5.3 The upfront fee and royalty accrued from licensing of any intellectual property arising from this collaboration to other PARTY (IES) shall be shared between the PARTIES, the terms and conditions of which shall be the subject matter of a separate agreement between the PARTIES.
- 5.4 The PARTIES shall not assign any rights and obligations to any third PARTES without consent of the other Party.
